E-Circular

Pondicherry University subscribes to many e-Journals, e-Books and e-Databases, and many e-resources for its users. Access to all the e-resources is available through IP authentication by the relevant publishers, enabling the users on the Pondicherry University Campus to access all the available resources through the intranet.

RemoteXs (Remote Access) is a facility provided to all the Faculty members, off-campus Research Scholars and Part-time Research Scholars to access all the e-resources subscribed by Pondicherry University. The total number of licenses available for RemoteXs facility is only 700 which is sufficient to support the above categories of users. The staff and scholars of Pondicherry University Campus are not able to come to the campus so they are provided with Remote Login credentials as they can access the same from the Campus intra-network.

Due to the current pandemic situation, the Remote Access facility has been extended to the faculty and regular Research Scholars on request through e-mail. Recently all the 700 licenses were utilised and the Central Library could not provide more credentials of RemoteXS facility. Based on our request, the service provider has increased the number of licenses from 700 to 2000 till the Pandemic is over but not later.

Hence, it is requested that the Faculty and Research Scholars who are not having RemoteXscredentials so far and require such facility may please send the request through e-mail to <u>librarian@pondiuni.edu.in</u> with the following details :

Kindly note that all the users of the RemoteXsshould sign and accept the rules of the PU Central Library and service provider. The terms and conditions document is attached herewith and you are requested to sign the same and attch the scanned copy with your e-mail. It is also requested that the users who have already provided with Remote Login Facility may also send the signed copy of the terms and conditions through email on or before 15/05/2021. Remote Login access will be continued only on receipt of the scanned copy of the Terms and Condition. It is only for the individual user and NOT shared to others and incase of any misuse, seviour action will be taken.

Terms of Use of E-Resources through Remote Login

General Restrictions

Access to the electronic resources listed on the AnandaRangapillai Library website is restricted to the users (Faculty, Research Scholars and Students) of Pondicherry University ONLY.As per the license agreements for electronic resources with different publishers, the users should not

- Allow any unauthorised user to use the licensed content.
- Modify or create a derivative work of the licensed materials without the permission of the licensor.
- Remove, obscure OR modify any copyright OR other proprietary notices included in the licensed materials.
- Use the licensed materials for commercial purposes.
- Systematically download with the use of robots, spiders, or any automated programs for continuous downloading within a short span of time, downloading entire volume/issue/complete content.
- Distribute electronic resource contentto others.

Copyright

Copyright laws govern the making of photocopies and other reproductions of copyrighted materials, such as making copies of print or electronic articles for others.

Users must respect **international copyrightlaws** and the specific terms of database providers regarding the storage and transmission of electronic information.

Consequences of Misuse of Electronic Resources

Usage and downloading of E-resources are monitored by the publishers round the clock. In case of any serious violation is detected from our campus or one of our remote users, publishers reserve the right to suspend access to their E-resource for the entire campus immediately.

The Library Administrator would be notified of the suspension of service and would then investigate the situation, taking steps to ensure that the violation would NOT happen again. Once the situation is resolved, the service is generally restored. Frequent breaching of the licence agreement will result in the withdrawal of electronic access rights for the University.

Violations of restrictions or any other terms of use stipulated by the provider is a grave offence, and will result in the withdrawal of electronic access rights and the possible imposition of further institutional sanctions. In all those cases, University will take serious disciplinary action on those individuals.

Declaration by the User

I acknowledge and agree that E-resources and their content are protected by copyright and their use is subject to limitations given in theagreements. I will **NOT VIOLATE** the copyright of E-resources and **terms** of use of E-resources. I will take all precautions to maintain the integrity of passwords and any other security measures. Therefore, I hereby declare that I am fully aware that any misuse/breach of the above will lead to discontinuation of access rights to the e-resources, delinquent of library membership and disciplinary action by the University authorities.
